注意事項Note

(1) 此表格適用於申請電子證書（機構）"具自動交換資料功能"。申請人須就每一位獲機構授權使用電子證書（機構）"具自動交換資料功能"登入稅務局的「自動交換資料網站」/「國別報告網站」/「支柱二網站」的授權用戶，遞交一份附加申請表格。

(2) 如屬電子證書（機構）“具自動交換資料功能”之新申請，申請人須填妥本附加申請表格，並附上有關的文件，連同香港郵政電子證書（機構/ 保密/ 伺服器）申請表格 (CPos 798F) 一起遞交。

(3) 如屬現有的電子證書（機構）之續期申請，並欲增加"具自動交換資料功能"，申請人須填妥此附加申請表格及附上有關的文件，連同“香港郵政電子證書（機構）－證書續期表格” (CPos 792G_C) 一起遞交。

(4) 授權用戶之香港身份證或護照副本須連同此附加申請表格一起遞交。授權用戶須在香港身份證或護照副本上簽署，簽署須與此附加申請表格的簽署相同。

(1) This form is used for applying for the e-Cert (Organisational) with AEOI Functions. The Applicant shall submit one supplementary application form for each Authorised User who is authorised by the Organisation to use the e-Cert (Organisational) with AEOI Functions to access the AEOI Portal / CbC Reporting Portal / Pillar Two Portal of the Inland Revenue Department ("IRD").

(2) For new application of e-Cert (Organisational) with AEOI Functions, the Applicant shall submit the supplementary application form(s) and the relevant supporting documents together with the "Application Form for Hongkong Post e-Cert (Organisational/Encipherment/Server) Certificate" (CPos798F).

(3) To add the AEOI Functions to the existing e-Cert (Organisational) upon renewal application, the Applicant shall submit the supplementary application form(s) and the relevant supporting documents, together with the "Hongkong Post e-Cert (Organisational) Certificate – Certificate Renewal Form" (CPos792G).

(4) A copy of the Authorised User's HKID card or passport shall be submitted together with the supplementary application form. The Authorised User shall sign on the copy of his/her HKID card or passport with the same signature as he/she signed in this supplementary application form.
